ON THE OPENING OF CANDIDATURES FOR THE POSTS OF CHAIRPERSONS, VICE-CHAIRPERSONS OF THE BOARDS OF DIRECTORS OF THE DIVISIONAL FOOTBALL LEAGUES AND DELEGATES OF THE REGIONAL GENERAL ASSEMBLIES.

The Electoral Committee hereby informs interested persons that candidatures for the posts of Chairpersons, Vice-Chairpersons of the Boards of Directors at the Divisional Football Leagues and Delegates of the Regional General Assemblies of FECAFOOT shall be received upon the publication of this press release.

I-General Conditions of Eligibility

Every candidate for the position of member of the Board of Directors of the league must comply with following the eligibility requirements:

- (a) shall be a Cameroonian citizen enjoying his/her civil rights;
- (b) shall be at least 21 years and at most 70 years old;
- (c) shall not have been sentenced to a definite term of imprisonment exceeding 3 (three) months without suspension;
- (d) shall not have been sentenced to a definite term of imprisonment subject to a suspended sentence or probation of more than 6 (six) months;
- (e) shall not have been suspended by a judicial body for a minimum of 2 (two) years on discipline-related issues and/or infringement of sports ethics within the five years preceding the elective General Assembly.
- shall have played an active role in football as a patron, a promoter or a director of a football team or school, player or former player, coach, referee, sports doctor, official of a football club, and sports journalist;

Application Files


The application file for the positions of Chairperson, vice-Chairpersons of the Boards of Directors of the leagues and Delegates of the General Assembly of the Regional League shall include:

A statement of candidacy according to the model provided by FECAFOOT and signed personally by the candidate; this model is available on the FECAFOOT website and can

be downloaded or obtained from the General Secretariat of the Divisional League;

- One (01) declaration on honour for candidates subject to incompatibility with the functions of the League Chair;
- A certificate of Non-conviction dated less than three (03) months;
- Five (05) letters of endorsement from delegates at the General Assembly of the Divisional League for candidates running for the positions of Chair, Vice-Chairs of the Board of Directors;
- A sports curriculum vitae including relevant contacts of the candidate (telephone, email address);

This curriculum vitae shall specify the active role played by the candidate in the area of football (promoter of a football team or school, player and former player, league official, trainer, referee, sports doctor, football club official, sports journalist during the four years prior to the submission of his/her application);

- A legalized copy of the candidate's national identity card;
- One (01) integrity questionnaire based on the model issued by FECAFOOT, filled in and duly signed by the candidate for the post of Chairperson.

Two (02) copies of the file (the original and a copy) shall be received in return of a receipt indicating all documents submitted by candidates. However, candidates shall have a two-day (02) deadline, that is, till 3 September 2021 at 06:00 P.M to complete their file or to replace one or more documents that do not comply.
