Press release No. 09 / FECAFOOT/CE/PDT/CE/2021 of 6 October 2021 to
Launch the Submission of Candidatures for the Positions of Chairpersons,
Vice-Chairpersons and Members of the Boards of Directors of Regional
Football Leagues and Delegates of FECAFOOT Elective General Assembly.

The Electoral Committee hereby informs all concerned that candidatures for the posts of Chairpersons and Vice-Chairpersons of the Boards of Directors of the Regional Football Leagues and for the posts of delegates of the Regional Leagues at the Regional Assemblies of the Football Leagues shall be received as from the publication of this communiqué.

I- General Eligibility Conditions

- All candidates for the position of Chairperson, Vice-Chairpersons of the Board of Directors of the Regional League and Delegates of the Regional Leagues at the Football Leagues Regional Assemblies shall fulfil the following eligibility conditions:

- a- shall be a Cameroonian citizen enjoying his/her civic rights;

- b- shall be at least 21 years old and not more than 70 years old

- c- shall not have been sentenced to a non-suspended penalty involving deprivation of liberty of over three (03) months ;

- d- shall not have been sentenced to a final custodial term with a simple suspended sentence or probation exceeding six (06) months;

- e- shall not have been sentenced to a suspension of at least two

(2) years for disciplinary offences and/or violation of sports ethics by a judicial body in the five years preceding the elective Assembly;

- f- shall have played an active role in football as promoter of a team or a football school, player or former player, league official, coach, referee, sports doctor, football club official, sports journalist.

II- Constitution of Candidacy File

The candidature file for the positions of Chairperson, Vice-Chairpersons, members of the Board of Directors of the Regional Leagues and Delegates at the Elective General Assembly of FECAFOOT shall include:

- A (01) declaration of candidacy as per the model provided by FECAFOOT and personally signed by the candidate; this model is available on the FECAFOOT website and can be downloaded or obtained from the General Secretariat of the Regional League;
- One (01) statement of honour for candidates subject to incompatibility with the office of Chairperson of the League;
- A (01) Certificate of non-conviction (criminal record) dating less than three (3) months;
- A (01) a Certificate of nationality
- Five (05) letters of endorsement from delegates at the General Assembly of the Regional League;
- A (01) sports curriculum vitae including relevant addresses of the candidate (telephone, email address);

This curriculum vitae shall outline the active role played by the applicant in football (team or football school promoter, current or former player, league official, coach, referee, sports doctor, football club official, sports journalist during the four years preceding the application);

As regards the position of chairperson, the candidate shall have played the said role during the four years preceding his/her submission of the application.

- A (01) legalized copy of their national identity card;
- One (01) integrity questionnaire as per the model issued by FECAFOOT, filled in and duly signed by the candidates for the positions of Chairperson, Vice-Chairpersons and members of the Board of Directors;

Two (02) copies of the file shall be produced, (the original and a copy), and received in return for a receipt listing all the documents submitted. Applicants shall, however, have a period of two (02) days, that is, until 13 October 2021 at 6.00 p.m., to complete their file or to replace one or more documents that do not conform to requirements.
