## DECISION N° /FECAFOOT/CR/2021 OF THE COMMISSION FOR APPEALS OF LITIGATION SITTING IN ELECTORAL DISPUTES

#### IN THE MATTER OF

PRISON FOOTBALL CLUB-BUEA DEMANDING THE CANCELLATION OF MADAM TANG ENOW EPOUSE TAH R ROSE NOT TO PARTICIPATE IN THE REGIONAL ELECTIVE GENERAL ASSEMBLY OF 1<sup>ST</sup> NOVEMBER 2021.

Mindful of the constitution;

Mindful of Law Nº 2018/014 of 11 July 2018;

Mindful of the FIFA Statutes;

Mindful of the Statutes, Codes and Regulations of FECAFOOT;

Mindful of Point 235 of the Arbitration decision of TAS 2019/A/6258, AS OLYMPIQUE de Meiganga and others **AND** FECAFOOT of 15<sup>th</sup> January 2021;

Mindful of the Decision of **FIFA** of 6<sup>th</sup> January 2021, the 19<sup>th</sup> and 26<sup>th</sup> February 2021 confirming that the Executive Committee remains in place since 2018 and its President, Mr. SEIDOU MBOMBO NJOYA being the legitimate executive head of FECAFOOT;

Mindful of the TAS Mail of 03 March 2021 confirming that Mr. SEIDOU MBOMBO NJOYA remains the legitimate representative of FECAFOOT;

Mindful of the report of the Extraordinary General Assembly of FECAFOOT held on the 7<sup>th</sup> august 2021;

Mindful of the report of the elections of Presidents, Vice Presidents, Rapporteur and members of the Jurisdictional Organ and of the Commission for Appeals on Litigations concerning sporting activities;

Mindful of decision N° 006/ FECAFOOT /CE /2021 PUBLISHING THE LIST OF CANDIDATES FOR THE POSTS OF PRESIDENTS, VICE - PRESIDENTS, MEMBERS AND DELEGATES OF THE REGIONAL LEAGUES OF FOOTBALLAND THE DELEGATES TO THE REGIONAL GENERAL ASSEMBLY.

















This twenty nineth day, of the month of October, in the year two thousand and twenty one, the commission for appeals on litigations in sporting activities, consisting of the following members;

Decided on the above cited case on the following terms;

That on the 29 th of October 2021, PRISON FOOTBALL CLUB - BUEA through her president filed an appeal against decision N° 006/ FECAFOOT /CE /2021 PUBLISHING THE LIST OF CANDIDATES FOR THE POSTS OF PRESIDENTS, VICE – PRESIDENTS, MEMBERS AND DELEGATES OF THE REGIONAL LEAGUES OF FOOTBALLAND THE DELEGATES TO THE REGIONAL GENERAL ASSEMBLY in which they are asking for this commission to review the above decision by striking out madam TANG ENOW epouse TARH ROSE as delegate to the upcoming elective general assembly.

PRISON FOOTBALL CLUB- BUEA supports her case with the fact that by decision taken by the appeal commission of FECAFOOT which handled matters of the list of candidacy to the post of president, vice president and delegates to the general assembly of FECAFOOT, intoto, invalidated the candidacy of madam TANG ENOW epouse TARH ROSE what ever capacity during the upcoming electoral processes organised by FECAFOOT.

PRISON FOOTBALL CLUB-BUEA in the same appeal, argued that, madam TANG ENOW epouse TARH ROSE had been suspended from **all football activities for five years** following the decision of the homologation and disciplinary committee of 1st august of 2018 of the south –west regional league which five years are still running.

#### ON THE ADMISSIBILITY OF THIS APPEAL

This appeal is admissible haven been filed within the time frame fixed by the law organising appeal to this commission.

#### ON THE MERIT

Madam TANG ENOW epouse TARH ROSE haven been suspended by general forfeiture by the south –West regional league for five years cannot be allowed to vote or to be voted in any electoral process organised by FECAFOOT.

















That **article 93 sub 3 of the disciplinary Code of FECAFOOT** is to the effect that any president of a club who is imputed with general forfeiture is suspended for five years from participating in all activities organised by FECAFOOT.

That madam TANG ENOW epouse TARH ROSE was sanctioned by the homologation and disciplinary committee of the South –West region league on the 1rst of august 2018 with a general forfeiture.

That with this sanction pronounced against her, she cannot contest for any position in the electoral process or be authorised to vote for or against any candidate.

That from 1rst august 2018,to this day, 29 October 2021,in simple mathematical calculation, is not five years, meaning therefor that the time limit for her sanction to expire has not come to an end.

### By a unanimous decision of this commission it declares:

**Article 1:** The petition of PRISON FOOTBALL CLUB —BUEA is admissible haven been filed within the time frame prescribe by the rules governing appeals to the appeal commission of FECAFOOT.

Article 2: Decisions  $N^\circ$  006/ FECAFOOT/CE/2021 publishing the list of candidate to the positions of president, vice –president, members of the regional league and delegates of the regional general assemblies are hereby retracted .

**Article 3:** Madam TANG ENOW epouse TAHR ROSE is hereby disqualified to stand for any elective position and has no capacity to vote in the electoral process of the South –West regional league to be held on the 1<sup>st</sup> of November 2021.

**Article 4**: Order the publication of this decision in conformity with the rules and regulations in place.
