#### Resolution Nº 9

#### Resolution N° 10

The Executive Committee, approves the proposals of candidatures for the posts of chairpersons, vice-chairpersons, rapporteurs and members of the jurisdictional bodies of FECAFOOT.

#### Resolution N° 11

The Executive Committee approves the proposals to create Federal Commissions in charge of the management of the status of football educators, coaches and referees respectively.

#### Resolution Nº 12

The Executive Committee approves the proposed budget of FECAFOOT for the year 2022.

### Resolution N° 13

The Executive Committee approves the proposal to increase the monthly allowances of members of the Executive Committee.

## Resolution N° 14

The Executive Committee mandates the President of FECAFOOT to investigate and eventually denounce individuals who used customs and tax exemptions obtained by FECAFOOT from the Ministry of Finance for personal purposes.

# Resolution Nº 15

Following the presentation of the report of the Moore Stephens audit firm for the period between 2016 and 2021, the Executive Committee mandates the President of FECAFOOT to:

- Request clarifications from FIFA on the financial situation of FECAFOOT in their books;
- Contact Mr. TOMBI A ROKO to request for documents relating to the contracts signed during his mandate, for the construction of stadiums and other infrastructure;
- Initiate negotiations with Mr. MANGA ONGUENE, former National Technical Director, so as to find a happy end to the dispute between him and FECAFOOT;
- Call on individuals who received funds from FECAFOOT to produce the corresponding supporting documents within the shortest posssible delay;
- Undertake appropriate proceedings against defaulting persons for the recovery of the due sums.
