## FINAL COMMUNIQUE OF THE SESSION OF THE EMERGENCY COMMITTEE OF FECAFOOT HELD ON THE 06 APRIL 2024

On the sixth of April two thousand and eighty-four, an ordinary meeting of the Emergency Committee of the Cameroon Football Federation was held at the headquarters of the Cameroon Football Federation in Yaounde, convened by its President, **Mr Samuel ETO'O FILS**.

In addition to **Mr ETO'O FILS Samuel**, President of FECAFOOT, the following were present:

- Mrs EKO MENDOMO Céline, **1<sup>st</sup> Vice-President**;
- Mr ABDOULKARIMOU, **2<sup>nd</sup> Vice-President**;
- Mr DJAMPIR Arthur, **3<sup>rd</sup> Vice-President**.

Mr DJOUNANG Blaise, **Secretary General** of FECAFOOT, reported on the proceedings, the only item on the agenda being **the crisis arising from the appointment by the Minister of Sport and Physical Education on 2 April 2024 of the members of the management structures of the men's "A" selection (Seniors Fanion)**.

As the quorum was reached, the FECAFOOT Emergency Committee was able to deliberate validly in accordance with the provisions of **articles 40, paragraph 17 and 49, paragraph 3 of the FECAFOOT Statutes**.

Having examined the item on the agenda, the Emergency Committee,

- Anxious to respect the will of the first Cameroonian sportsman, **His Excellency Mr Paul BIYA**, President of the Republic of Cameroon, to put the law before men,
- Concerned about the application of this will, clearly expressed in this case in his Decree N°2014/384 of 26 September 2014, on the organisation and functioning of the National Football Selections,
- Anxious to respect the statutes and regulations of FIFA, CAF and FECAFOOT, has adopted the following resolutions:

### Resolution N°1

The Emergency Committee unanimously notes that FECAFOOT was not involved in the procedure leading to the appointment on 2<sup>nd</sup> April 2024 of the members of the

management structure of the Men's A (Senior) Selection, in disregard of the aforementioned texts.

### **Resolution N°2**

The Emergency Committee unanimously recommends to the President of FECAFOOT, in application of Article 4 of Decree No. 2014/384 of 26 September 2014 and Article 40, Paragraph 11 of the FECAFOOT Statutes, to submit to him, within seventy-two (72) hours, proposals for the appointment of members of the management structures of the national football selections.
