FINAL RELEASE OF THE CAMEROON FOOTBALL FEDERATION'S EMERGENCY COMMITTEE SESSION HELD OVER VIDEOCONFERENCE ON MAY 08, 2024

The year two thousand and twenty-four,

On the 8th of May, a session of the Emergency Committee of the Cameroon Football Federation was held by videoconference, convened by its President, **Mr. ETO'O FILS Samuel**.

Besides Mr ETO'O Fils Samuel, President of FECAFOOT, the following were present:

On the agenda were the following points:

1. Appointment of members of the technical and administrative management structure of the Cameroon men's "A" team, "THE INDOMITABLE LIONS";
2. Examination of the MINSEP/FECAFOOT Convention dated February 05, 2015.

With a quorum reached, the FECAFOOT Emergency Committee was able to conduct its deliberations validly in accordance with the provisions of **articles 40 paragraph 11 and article 49 paragraph 3, of the FECAFOOT Statutes.**

Having examined the points on the agenda, the Emergency Committee:

Given the urgency of preparing the Senior men's team for the 2026 World Cup qualifiers;

- With respect to the provisions of article 40 paragraph 11 of the FECAFOOT Statutes, which establishes the exclusivity of the Executive Committee in appointing all members of the technical and administrative management structure of the men's "A" national team;
- With respect to the provisions of Decree n° 2014/384 of September 26, 2014, on the organization and functioning of the National Football Selections, signed by the President of the Republic of Cameroon;
- With respect to the provisions of article 3 paragraph 2 of the aforementioned Presidential Decree, which only provides for joint management in financial matters;
- Given the financial sacrifices already incurred by the government in order to bring in foreign expertise, and in the hope of reaching an amicable solution;

The Emergency Committee unanimously took the following resolutions:

Resolution 1:

The Emergency Committee, by unanimous vote and on the proposal of the President of FECAFOOT, decides to appoint the members of the management structure of the Cameroon men's "A" "THE INDOMITABLE LIONS", as follows:

Resolution 2:

The Emergency Committee, unanimously instructed the President of FECAFOOT to communicate, with the utmost priority, the list of designated members of the management structure to MINSEP and FIFA; and to proceed with the official appointment of the designated persons.

Resolution 3:

Following FIFA's recommendation, the Emergency Committee unanimously mandates the President to set up a working group to review and make proposals for the revision of this convention in its entirety.
