FINAL RELEASE OF THE CAMEROON FOOTBALL FEDERATION'S EMERGENCY COMMITTEE SESSION HELD ON MAY 28, 2024

The year two thousand and twenty-four,

On May 28, a session of the Emergency Committee of the Cameroon Football Federation was held over videoconference, convened by its President, **Mr. ETO'O FILS Samuel**.

Besides Mr ETO'O Fils Samuel, President of FECAFOOT, the following were present:

- Madam EKO MENDOMO Céline, **1st vice-president**;
- Mr ABDOULKARIM, **2nd vice-president**;
- Mr DJAMPIR Arthur, **3rd vice-president**;
- Mr MBIGHA NJAH Felix, **4th vice-president**.
- Mr DJOUNANG Blaise, **rapporteur**.

A single item was on the agenda, that of the measures to be taken with regards to the inappropriate behaviour of the head coach and his assistants following the summon addressed to them on May 24 2024.

The FECAFOOT emergency committee having attained its quorum, was able to deliberate in accordance with the provisions of **articles 40 paragraph 11 and 49 of FECAFOOT Statutes**.

At the close of the discussions on the item on the agenda, the Emergency Committee:

- Considering the urgent need to prepare the National team for the 2026 World Cup qualifiers;
- Considering the provisions of article 40 paragraph 11 of FECAFOOT Statutes establishing the exclusivity of the Executive Committee in appointing all members of the technical and administrative support staff of the Senior Men's National Team;
- Considering the very pertinent prescriptions of Decree no2014/384 of September 26, 2014, on the organization and functioning of the National Football Teams, signed by the **President of the Republic of Cameroon**;

- Considering the meeting convened by the Secretary General on May 28, an initiative of the President of FECAFOOT which aimed at preparing the matches counting towards the 2026 World Cup qualifiers;
- Considering the incident that occurred within the framework of this meeting, during which some unacceptable behaviour prevented the meeting from taking place, especially the attitude of the Technical Advisor N°2 to the Ministry of Sports and Physical Education, who, not having been invited to the meeting, demanded that the President of the Federation communicate the agenda of the meeting, an instruction he had received from the Minister of Sports, failing which the meeting would not take place;
- Considering the disrespectful comments made by head coach **Marc BRYS** towards the President of FECAFOOT;
- Considering that the Emergency Committee, with the unanimity of its members, observes that the President of FECAFOOT, during this meeting, wished to remind Mr. MARC BRYS of the risks he runs for the National Selection in view of the various shortcomings listed below:
 1. The manifest refusal to attend the first working session organised by the Secretary General on 10 May 2024;
 2. Publication of players' list and organization of a press conference in violation of FECAFOOT procedures;
 3. Refusal to communicate training schedules;
 4. Taking isolated work initiatives and disclosing information on players to third parties and the media without prior approval from FECAFOOT;
 5. Failure to communicate the final list of players selected for matches within the allocated time.
- Considering that the Emergency Committee, with the unanimity of its members, notes that these failures constitute a serious fault of the head coach and his assistants towards FECAFOOT; that faced with this situation, an outright refusal to collaborate on the part of the head coach, the federation is within its rights to draw all the necessary consequences; 3

- Considering that on February 10, 2024, in his speech to the Cameroonian youth, **The President Of The Republic of Cameroon** reiterated his desire to honour the image of the National Football team by providing it with adequate technical staff;
- Considering that the current challenges, especially the matches scheduled for June 08 and 11, 2024 against Cape Verde and Angola as part of the 2026 World Cup qualifiers, require that urgent measures be taken for the effective deployment of members of the technical, administrative and medical support staff:

The Emergency Committee unanimously adopted the following resolutions:

Resolution 1:

The Emergency Committee unanimously decides, on the proposal of the President of FECAFOOT, to appoint the interim members of the Cameroon Men's Senior National Team "INDOMITABLE LIONS" as follows:

INTERIM HEAD COACH	MR NDTOUNGOU MPILE MARTIN
INTERIM ASSISTANT COACH	MR PAGOU DAVID
INTERIM PHYSICAL PREPARER	MR TINKEU NGUIMGOU NARCISSE

Resolution 2:

The Emergency Committee, unanimously, gives the President of FECAFOOT full powers to communicate, as a matter of extreme urgency, the list of interim members of the management body as designated to MINSEP and FIFA; to proceed with the conformation of the acts of assumption of office of the persons designated.
