FINAL COMMUNIQUE OF THE FECAFOOT ORDINARY GENERAL ASSEMBLY HELD ON 16 NOVEMBER 2024 IN MBANKOMO

In the year two thousand and twenty-four and on the sixteenth day of November, the **President of the Cameroon Football Federation (FECAFOOT), Mr ETO'O FILS Samuel,** convened an Ordinary General Assembly of the Cameroon Football Federation at the CAF Centre of Excellence in Mbankomo to deliberate on the following items on the agenda:

- 1. Verifying that the convening and composition of the General Assembly are in conformity with the provisions of the Statutes of FECAFOOT
- 2. Approval of the agenda
- 3. Keynote address by the President
- 4. Appointment of three (03) delegates to supervise the minutes
- 5. The appointment of two (02) scrutineers
- 6. Examination of a proposal to withdraw a member's accreditation
- 7. Approval of the minutes of the previous General Assembly
- 8. Presentation of progress reports
- 9. Presentation of the consolidated and audited balance sheet and the profit and loss account
- 10. Approval of the annual financial statement, after presentation by the Independent Auditing Firm
- 11. Approval of the ordinary budget
- 12.the admission of a member, if applicable
- 13. Proposed amendments to certain provisions of the Statutes of FECAFOOT, the Financial Regulations, the General Internal Rules for the Award of Contracts and the Organizational chart
- 14. The ratification of a member's articles of association, if applicable
- 15. The designation of the independent audit firm, if applicable
- 16. Update on the Recommendations of FIFA regarding the revision of the MINSEP/FECAFOOT Agreement of 05 February 2015
- 17. Examination of the situation of clubs
- 18. Update on Leagues
- 19. Election of members of the Executive Committee to fill vacancies

Fifty-three (53) members out of sixty-four (64) convened were present at the said Ordinary General Assembly.

A quorum was reached and the General Assembly was able to deliberate legitimately in accordance with the provisions of articles 22, 23, 24, 25, 26, 27, 30, 31, 32, 33, 38 and 66 of the FECAFOOT Statutes, and 1, 4, 5, 12, 13, 15 et seq. et seq. of the FECAFOOT Electoral Code.

At the end of the discussions on each item on the agenda, the following resolutions were adopted:











Resolution N° 1

The General Assembly, by forty-six (46) members 'for' and one (1) 'against' out of fifty-three (53) present declare the withdrawal of the recognition of the National Union of Cameroonian Footballers (SYNAFOC) as a member of FECAFOOT, representing players.

Resolution N° 2

The General Assembly by unanimous vote of the members present approves the minutes of the General Assembly of 10 October 2023 held in Mbankomo.

Resolution N° 3

The General Assembly, by unanimous vote of the members present, takes due note of the consolidated and revised balance sheet as well as the profit and loss account of FECAFOOT for the financial year 2023.

Resolution N° 4

The General Assembly, by unanimous vote of the members present, unanimously approves the annual accounts of FECAFOOT as at 31 December 2023 audited by NEWKO Audit Sarl.

Resolution N° 5

The General Assembly, by unanimous vote of the members present, unanimously adopts the budget of FECAFOOT for the financial year 2024, regularises and validates the expenses incurred since the beginning of the said financial year.

Resolution Nº 6

The General Assembly, by unanimous vote of the members present, unanimously approves the admission of the National Footballers Association (ANFC) as a member of FECAFOOT.

Resolution N° 7

The General Assembly, by unanimous vote of forty-three (43) of the members present, adopts, after amendment of certain provisions, the proposed modifications to the Statutes, the Financial Regulations, the General Internal Rules for the Award of Contracts and the FECAFOOT Organizational chart.











Resolution Nº 8

The General Assembly, by unanimous vote of the members present, ratifies the Statutes of the National Association of Footballers of Cameroon (ANFC).

Resolution N° 9

The General Assembly, by unanimous vote of the members present unanimously, appoints the firm NEWKO Audit as independent auditor.

Resolution N°10

The General Assembly, by unanimous vote of the members present, authorises the Executive Committee to continue its efforts to revise the MINSEP/FECAFOOT Convention of 05 February 2015 as prescribed by FIFA.

Resolution N° 11

The General Assembly, by unanimous vote of the members present, approves the changes to the names of certain clubs approved by the Executive Committee.

Resolution N° 12

The General Assembly by unanimous vote of the members present, validates the decisions taken by the General Secretariat with regard to the leagues.

Resolution N° 13

The General Assembly, under the supervision of the Electoral Commission, unanimously elects the new members of the Executive Committee.
