FINAL COMMUNIQUE OF THE SESSION OF THE EXECUTIVE COMMITTEE OF FECAFOOT HELD ON 15 NOVEMBER 2024 IN MBANKOMO

The Executive Committee of the Cameroon Football Federation (FECAFOOT) was convened by the **President of FECAFOOT**, **Mr Samuel ETO'O FILS**, at the CAF Centre of Excellence in Mbankomo on the fifteenth day of November of the year two thousand and twenty-four.

With a quorum reached, the FECAFOOT Executive Committee was able to deliberate and decide in accordance with the provisions of articles 39, 40 and 41 of the FECAFOOT Statutes, on the following items on the agenda:

- 6- Minutes and approval of decisions from the Emergency Committees;
- 7- Examination of a proposal to withdraw a member's certification;
- 8- Admission of a member if applicable;
- 9- Updates on the calendar of professional championships and other championships organized by FECAFOOT;













- 10- Review of the number of clubs to play in the MTN Elite Two Championship for the 2024/2025 season;
- 11- Update on the rules governing the various championships;
- 12- Presentation of activity reports:
 - President of FECAFOOT
 - General Secretariat of FECAFOOT.
- 13- Approval of the audit report by the independent auditor firm;
- 14- Examination of the draft budget of FECAFOOT for the 2024 financial year;
- 15- Proposed amendments of certain provisions of the statutes of FECAFOOT, the Financial Regulations, the General Rules for the Award of Contracts and the organizational chart;
- 16- Examination of requests to change the names of some clubs;
- 17- Update on the appointment proposals made by the President of FECAFOOT;
- 18- Miscellaneous;
- 19- Reading of the final communiqué.

After examining the aforementioned points, the Executive Committee took the following resolutions:

Resolution Nº 1

Resolution N° 2

The Executive Committee, by unanimous vote of the members present, recommends that the General Assembly withdraw the approval of the Cameroon National Footballers Syndicate (SYNAFOC) as a member of FECAFOOT.

Resolution N° 3

The Executive Committee, by unanimous vote of the members present, recommends that the General Assembly admit the National Association of Footballers of Cameroon (ANFC) as a member of FECAFOOT.













Resolution N° 4

The Executive Committee, by the unanimous vote of the members present, validates the calendar of the various FECAFOOT competitions for the 2024/2025 sports season.

Resolution N° 5

The Executive Committee unanimously decides that the MTN Elite Two professional championship shall be played with seventeen (17) clubs for the 2024/2025 sports season.

Resolution Nº 6

The Executive Committee unanimously adopts the regulations of the various FECAFOOT competitions for the 2024/2025 sports season.

Resolution N° 7

The Executive Committee unanimously approves the draft budget of FECAFOOT for the financial year 2024.
