## FINAL COMMUNIQUE OF FECAFOOT EXTRAORDINARY GENERAL ASSEMBLY ON 7 AUGUST 2025 IN MBANKOMO

In the year two thousand and twenty-five;

And the seventh of august, convened by its President, **Mr. ETO'O FILS Samuel, the Cameroon Football Federation (FECAFOOT)** held an Extraordinary General Assembly at the CAF Centre of Excellence in Mbankomo to brainstorm on the following items on the agenda:

- 1- **Verification of the conformity of the convocation and composition of the General Assembly with the Statutes of FECAFOOT;**
- 2- **Approval of the agenda;**
- 3- **Speech by the President;**
- 4- **Appointment of three (3) delegates to review the minutes of the Extraordinary General Assembly;**
- 5- **Appointment of two (2) scrutineers;**
- 6- **Approval of the minutes of the Extraordinary General Assembly of May 24, 2025;**
- 7- **Consideration of the proposal to withdraw the approval and exclude a member;**
- 8- **Admission of a member, if applicable;**
- 9- **Ratification of a member's statutes, if applicable;**
- 10- **Election of members of the Electoral Commission;**
- 11- **Update on the election schedule;**

**Reading of the final communiqué.**

The Presiding Committee of the Extraordinary General Assembly was composed as follows:

- **Chair:** **Mr. ETO'O FILS Samuel**, President of the Cameroon Football Federation (FECAFOOT);
- **Rapporteur:** **Mr. MANDONG Isaac Noé**, Secretary General of the Cameroon Football Federation (FECAFOOT);

The following personalities also took part in the proceedings of the Extraordinary General Assembly:

- The Representatives of the Ministry of Sports and Physical Education, who were duly summoned, but were unable to attend;

**Maître MEWOLI KAMABEW Rose**, Bailiff at the Court of Appeal of the Centre and the Courts of Ngoumou, Office located at Montée de la Mairie de Mbankomo, P.O. Box: 158, Tel: 677 91 47 07, attended the proceedings and verified the identity of voters and ensured compliance with the electoral procedure, in accordance with the provisions of Article 26 of the FECAFOOT Electoral Code.

Forty-eight (48) of the fifty-six (56) members convened were present at the Extraordinary General Assembly.

With the established quorum present, the General Assembly was able to validly deliberate in accordance with the provisions of Articles 22, 23, 24, 25, 26, 27, 30, 31, 33, and 66 of the FECAFOOT Statutes, and Articles 1, 4, 5, 12, 13, 15 of the FECAFOOT Electoral Code.

Following discussion of the items on the agenda, the following resolutions were adopted:

#### **Resolution N°1**

The General Assembly, by unanimous vote of the members present, approves the minutes of the Extraordinary General Assembly held on May 24, 2025.

#### **Resolution N°2**

The General Assembly, by forty-eight (48) members out of forty-eight (48) members present, pronounces the withdrawal of approval and exclusion of the Cameroon Association of Football Referees (ACAF) as a member of FECAFOOT.

#### **Resolution N°3**

The General Assembly, by unanimous vote of the members present, admits the Cameroon Association of Football Referees and Assistants Referees (ACAAF) as a member of FECAFOOT representing referees and Assistants Referees.

#### **Resolution N°4**

The General Assembly, by unanimous vote of the members present, ratifies the Statutes of the Cameroon Association of Football Referees and Assistants (ACAAF).

#### **Resolution N°5**

The General Assembly, by unanimous vote of the members present, under the guidance of the Electoral Commission, proceeds to elect the new members of the said Commission as follows:
