FINAL COMMUNIQUE FROM THE FECAFOOT EXECUTIVE COMMITTEE MEETING HELD ON 3 JULY 2026 IN YAOUNDE (WARDA)

Resolution No. 1

The Executive Committee, by a unanimous vote of the members present, approves the agenda for this session.

Resolution No. 2

Resolution No. 3

The Executive Committee, by a unanimous vote of the members present, appoints the Presidents, Vice-Presidents, Rapporteurs, and Members of the Standing Committees, after reviewing the nominations submitted by the Members of the Executive Committee.

Resolution No. 4

The Executive Committee, by a unanimous vote of the members present, recommends that clubs submitting applications should first provide the receipts for the name change obtained from the administrative centre.
