Defining the Registration Requirements for Professional Clubs for the 2026/2027 Sports Season

To:

- The President and Secretary General of the Transitional Council for Professional Football of Cameroon;
- The President and Secretary General of the Cameroon Women's Football League;
- The Presidents of Professional Championship Clubs.

I have the honour to inform you that, for the 2026/2027 sports season, the registration of professional clubs shall take place exclusively between the 15th of July and 31st August 2026.

Accordingly, the clubs retained following the homologation of the 2025/2026 MTN Elite One, MTN Elite Two and Guinness Super League championships, as well as those promoted through the 2026 Interpools Tournament, and wishing to participate in competitions organised by FECAFOOT, shall upload the following documents to the Club Folder in the FIFA Connect Registration System and deposit them at the FECAFOOT mail service against discharge.

- The Club Statutes;
- The Club Internal Regulations;
- The Club Disciplinary Code;
- The Club Registration Form;
- The Club Logo;
- Registration of one U-15 and one U-17 team in Youth Football;
- Registration of one team in Beach Soccer or Futsal;
- The minutes of the General Assembly held after the 2025/2026 sporting season, attended by a FECAFOOT representative;
- The composition of the Executive Board or Management Committee, indicating the names and addresses of its members. Members of the Committee must be of legal age;
- A document specifying the Club's primary and secondary official colours;

- The Articles of Association of the Company established within the Club;
- The agreement between the Association and the Company;
- Proof of payment of the competition registration fee;
- Proof of payment for at least sixteen (16) player licences;
- Proof of payment for at least eleven (11) U-17 and U-15 player licences;
- A bank account certificate and bank account details (RIB);
- The budget forecast for the forthcoming sporting season;
- The financial statements for the previous season certified by a Chartered Accountant;
- A location plan of the Club's registered office, equipped with an operational telephone line, a dedicated electronic mail (e-mail) address, and signed by the President of the relevant Regional League or a member of the FECAFOOT Executive Committee for the region concerned;
- A location plan of the training ground, signed by the President of the relevant Regional League or a member of the FECAFOOT Executive Committee for the region concerned;
- A Head Coach and Assistant Coaches duly qualified, holding a CAF A Licence for the Head Coach and a CAF B Licence or Federal A Licence, or their equivalent, for the Assistant Coach;
- The employment contract between the Administrative Secretary or General Manager and the Club;
- The employment contract between the Physiotherapist and the Club;
- A certificate confirming subscription to a Sports Civil Liability Insurance Policy covering players and coaches under contract.

Strict compliance with the provisions of this Circular is hereby required.
